This form should be used to apply for a Visitor's Firearm/Shotgun Permit. It should be completed by a person resident in Great Britain on behalf of a visitor who wishes to possess firearms to which Section 1 of the Firearms Act 1968 applies or possess, purchase or acquire any ammunition to which that Section applies whilst in Great Britain or to possess a shot gun to which Section 2 of the Act applies

The person making the application is referred to in this form as the Sponsor. The completed form should be sent to the Sponsor's local chief officer of police.

Firearms to which Section 1 applies include any smooth bore gun which has a barrel with a length of less than 60.96cm (24") or a bore greater than 5.08cm (2") in diameter, or which has a non-detachable magazine capable of holding more than two cartridges, or a detachable magazine.

It is an offence for any person knowingly or recklessly to make a false statement for the purpose of procuring the grant of a permit.
